Subject: Counselling and On the Spot Admission to MBA Programme for the Academic Year 2023-24 for Regular Category.

We are pleased to inform you that the result of Entrance Test for Admission to Master of Business Administration programme against vacant seats held by this University on 11 June 2023 has been declared on 16 June 2023.

Based on the rank in the Entrance Test and choice of Institute exercised by you, you have been provisionally allotted Institute of Management and Research, New Delhi for admission to MBA Programme at Bharati Vidyapeeth (Deemed to be University)

You are required to be physically present for counselling and on the spot admission on 26 June, 2023 at 10.00 a.m. at Institute of Management and Research, (BVIMR), A-4, Rohtak Road, Shiva Enclave, Paschim Vihar, New Delhi 110063

It is compulsory for either you or your representative to attend the counselling to claim for admission. In this session of provisional admission, you will be called for counselling in accordance with the merit number in the regular category merit list and will be offered admission as per the availability of the vacancy at that particular point of time in the counselling session. If you remain absent when your name is announced for counselling, you stand to lose claim for admission.

Important Instructions:

- 1) The following certificates in original along with two self-attested copies each of the same are to be submitted at the time of counselling and on the spot admission. (a) Statement of marks (Last qualifying examination). (b) Copy of Aadhaar card. (c) Two passport size recent photographs. The remaining documents as mentioned in the information brochure must be submitted later.
- 2) The students who are given provisional admission will be required to pay the entire amount of tuition fees of **Rs. 3,25,000/- (Rupees Three Lakh Twenty Five Thousand)** on 26 June, 2023 at the time of admission. The above fees are for first year. (The fees shall be revised upwards @ 5% per annum)
- 3) The Fee shall be paid through one of the following modes:
 - i) Demand Draft drawn in favour of "Director BVIMR New Delhi" payable at New Delhi OR
 - ii) Online mode through our Fees portal <https://www.bharatividyaapeethfees.com>On payment of the fees, the provisional admission will be completed. In case the candidate fails to remit the entire amount of fees, he/she will lose the claim for admission.
- 4) If you desire to have hostel accommodation, limited hostel accommodation is available on the campus both for boys and girls. The same will be allotted on first come first serve basis.
- 5) As you are aware of the total intake mentioned in the information brochure, it may happen in the case of some candidates that admission to the Programme would be over before their turn comes up. It will then not be possible to consider them for admission. In such a situation, we do not owe any responsibility.
The commencement of the academic session for the first-year student will be informed by the institute. All students who will be given provisional admission to the respective programme have to compulsorily attend from that day.
