NOTICE FOR MBA FINAL YEAR (SEMSTER IV)

## **Dear Students**

## Welcome to the final semester of your MBA!!!

Before the commencement of the session, let us take this opportunity to congratulate you for your successful journey towards your final semester.

There are a few important points which we want to put across:

- a) You all are expected to join in for your classes from 13th Jan, 2021 (Wednesday). Kindly refer to your time table for further details.
- b) Kindly note that you are allowed to carry any number of backlogs papers of semester I and II while going to semester III. However, you must clear all papers of semester I and II so as to become eligible for appearing in examination at semester IV. It is also to be noted that you must clear all your semesters to qualify for MBA degree.
- c) Owing to the final placement pressure, it has been decided that CRC shall conduct Aptitude Test for 100 Marks in place of 1st internals.
  - It is expected from all of you (even the students placed now and by then) that you
    will appear in the above mentioned Aptitude test and also II internal in which
    the 100% syllabus shall be covered. Any failure in attempt will be marked as
    ZERO.
- d) Regarding Continuous Evaluation pertaining to various subjects:
- i) For the students who have not been placed: 75% aggregate attendance is a must for examinations and placements. Non maintenance shall invite academic penalty and zero marks in II internals. All three continuous evaluation to be submitted. All academic activities including exams to be undertaken.

- ii) For the students who have been placed but joining is towards the end of the semester: 75% aggregate attendance is a must. Non maintenance shall invite academic penalty and zero marks in II internals. All three continuous Evaluation to be submitted. All academic activities including exams to be undertaken.
- mandatorily undertaken per subject. (If CES 1 has been attempted in class before placement then the student will only be required to submit placed CES 2 i.e. Academic Engagement and if a student has attempted CES I and 2 in class before placement then no placed CES is required to be attempted). Second internal exams and Aptitude test to be taken with 100% syllabus coverage.
  - iv) For the students who have been relieved: Two Placed CES (Case Study& Academic engagement) to be mandatorily undertaken per subject. Second internal exams and Aptitude test to be taken with 100% syllabus coverage
- v) Nature of CES to be submitted by students placed and join within the semester or relieved students: Two CES activities will be conducted

  Placed CES 1: Case Study 10 marks (online submission) to respective subject faculty.

  Placed CES 2: Academic engagement 10 marks, i.e. past two year question papers to be solved for all respective subjects which will be submitted (online) to respective subject faculty.
- vi) The attendance marks for placed students during the semester will be as mentioned below:

5 Marks for off campus placements

7 Marks for on campus placement
