Step 1: Visit the site nad.ndml.in

Step 2: Click register

(A) Selection of with Adhar

Step 3: On the new page click the link under "To generate Adhar paper"

Step 4: On the new window

- Enter Adhar No. ; Security key
- Wait for OTP
- Enter OTP to download offline Adhar

Step 5: Come back to the registration page and upload the offline Adhar. File password is the security key.

Click Submit

Step 6: On the next page

- Fill the necessary details, create **Login ID**
- For college registration select :-
Institute type: stand alone
State: Maharashtra
University: Bharati Vidyapeeth (Deemed to be university) Pune
College: Bharati Vidyapeeth Institute of Management and Research

Step 7: You will receive an OTP. Enter the same to complete the registration.

Step 8: Verify your account details through verification link sent through mail to activate account.



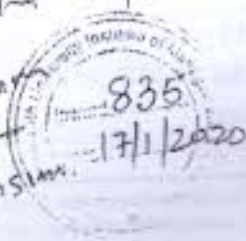
